Pipe; one (1) 8" Valve; two (2) 6" Valves; seven (7) 2" Valves; two (2) Fire Hydrants; and ten (10) Valve Boxes as shown on a drawing entitled "W. N. Leslie, Inc. to Commissioners of Public Works of the City of Greenville, S. C.", dated August 21, 1984, attached hereto and made part of this conveyance.
