Mareon C. Bryant, her heirs and assigns forever:

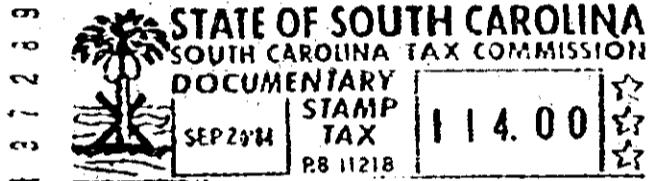
