the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto SHIRLEY L. WHITMIRE, her heirs and assigns forever, ALL OUR UNDIVIDED RIGHT, TITLE INTEREST, EQUITY AND ESTATE IN AND TO THE FOLLOWING PROPERTY:

ALL that piece, parcel or lot of land, with all improvements thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, and being more particularly described as Lot 67, Section 1 as shown on a plat entitled, "Revised Portion Section 1, Subdivision of Village Houses, F. W. Poe Mfg. Co., Greenville, S. C." made by Dalton & Neves, September 1956, and recorded in the R.M.C. Office for Greenville County in Plat Book LL at Page 113. According to said plat, the within described lot is also known as No. 8, Second Avenue, and fronts thereon 77 feet.

There is situate upon the above-described lot a portion of a four-car garage. By accepting this deed, the Grantee agrees, and hereby binds her heirs and assigns, that she will properly maintain the portion of the garage situate on said lot, that she will not alter such portion of said garage or remove the same without the written consent of the owner or owners of the adjoining land on which the remainder of the garage is situate, and that in the event of such removal, with the consent of the adjoining owner or owners, she will construct any walls, reinforcements or other things required to make such remaining portion a complete building suitable for garage purposes.

Office for Greenville County; thence N. 41-12 W., with said Second Avenue a distance of 12 feet to a new corner; thence S. 48-58 W., with a new line to a new corner in the division line between Lots 33 and 68, an approximate distance of 96.4 feet; thence with said line S. 41-02 E., to the common corner of Lots 33, 34, 67 and 68, a distance of 12 feet; thence N. 48-58 E., with the division line
