part thereof; to exercise all rights of ownership in property

sue for, collect, receive, and give good receipts, acquittances,
discharges, accounts, receivables, claims, and demands, and
other personal property of every kind and description due
or owing or belonging to me or to which I am or may or shall
be entitled; to compromise and settle claims due to or by
me, to sell, assign, transfer, convey, and dispose of any
and all property, real or personal, by mortgage, pledge, or
otherwise of any or all property now or hereafter owned by
me, to borrow money and to give security by mortgage, pledge,
or otherwise of any or all property now or hereafter owned
by me, to renew or otherwise extend the time for payment of
any note or other obligation that may or shall be due and
owing by me; to endorse and either cash or deposit any check
or draft or other instrument for payment of any money to my
credit or account in any banking institution or savings and
loan association; to prepare, make, sign, and file any and
all tax returns of any and every kind and description, including
Federal and State income tax returns, required to be prepared,
made, signed or filed by me and to act for me in all matters
relating to or pertaining to or arising out of any such return
and to my liability for taxes as shown thereby; and to make,
sign, and execute all deeds, contracts, notes, mortgages,
