ALL that piece, parcel or lot of land in Chick Springs Township, Greenville County, South Carolina, located on the Eastern side of the Suber Road and on Princess Creek about 3 miles south of the City of Greer, containing 7.40 acres, more or less, and being a portion of the W. A. Smith tract as shown on a plat of the Charles Miller Estate dated September 10, 1938, said plat being recorded in the RMC Office for Greenville County in Plat Book CCC at Page 5 and having the following metes and bounds, to-wit:
