the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

B. F. Lewis and Anna L. Lewis, their heirs and assigns forever:

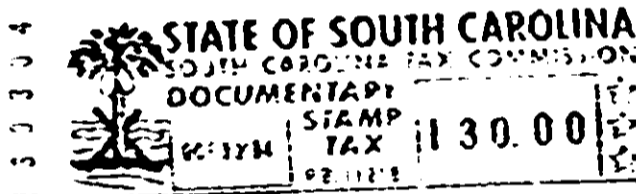
ALL those piece, parcels, or lots of land, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township being known and designated as Lots 1 and 2 on plat of property of W. E. Caldwell recorded Plat Book X at page 63-A and further shown on a plat of property of Dan H. McKenney and recorded in Plat Book YY at page 45 and according to said plat as having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of East Lee Road at joint corner now or formerly owned by Bishop and running thence along the line of Bishop Property North 46-53 W. 100.2 feet, more or less, to a point, thence N.42-52 E. 129.56 feet to an old iron pin on the westerly right of way of Caldwell Street, thence with said right of way of Caldwell Street, S. 47-8 E. 175 feet to a point on Lee Road; thence with Lee Road S.-72-46 W. 150 feet to the point of beginning. -12-271-115.6-4-17,18

Subject to an easement in favor of the State of South Carolina Highway Department for road purposes over that portion of the subject property lying with 18 feet of the center line of Lee Road.
