KNOW ALL MEN BY THESE PRESENTS, that we, Clarence V. Glenn and Roy A. Lockaby

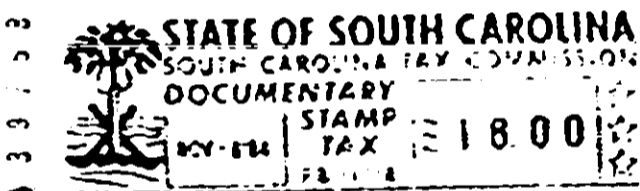
in consideration of Eight Thousand and No/100-----(\$8,000.00)----- Dollars,
