KNOW ALL MEN BY THESE PRESENTS, that I, JANICE A. DAVIS

in consideration of One (\$1.00) Dollar, Love and Affection----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JACK H. DAVIS, JR., his heirs and assigns forever;

A completed and undivided one-half (1/2) interest in and to all that piece, parcel or tract of land in the County of Greenville, State of South Carolina, in Grove Township, being shown on plat of property of R. E. Dalton made November 1947 and recorded in Plat Book "S", at page 15 R/C Office for Greenville County and being a portion of Tract No. 23, containing 2.9 acres and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Sunny Lane at the joint front corner of Tract No. 23 and Tract No. 22-A and running thence along the joint line of said tracts, North 2-19 East 488 feet to an iron pin at branch; running thence with the branch as the line, South 85-10 West 205 feet to an iron pin in Tract No. 23; running thence through Tract No. 23 (a new line), South 2-19 West 425 feet; running thence South 53-48 East 38 feet to an iron pin on Sunny Lane; running thence along Sunny Lane, South 85-46 East 175 feet to an iron pin, the point of beginning.
