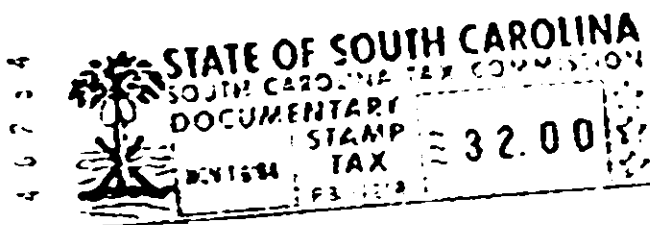
In consideration of Sixteen Thousand and no/100----- Dollars,
