

J. Taxes and Expenses. To pay taxes, assessments, her compensation as Attorney-in-Fact and other expenses incurred in the collection, care, administration and protection of my property.

III. Construction. The powers enumerated or referred to in this Power of Attorney are not intended as any limitation on the general power which my Attorney-in-Fact shall have to do anything I might have done for myself. Any power may be exercised by my Attorney-in-Fact upon such terms and conditions as my Attorney-in-Fact sees fit and may be exercised with reference to periods that extend (or may extend) beyond the duration of this Power of Attorney. This Power of Attorney and the powers set forth herein shall be liberally construed in conformity with the laws of South Carolina.

IV. Prohibitions. Notwithstanding the foregoing provisions of this instrument, my Attorney-in-Fact is expressly prohibited from altering, amending or modifying in any way any other instrument executed by me prior or subsequent to the execution of this Power of Attorney for the purpose of deriving personal benefit, monetary or otherwise, it being my intention that my Attorney-in-Fact should not use the powers granted herein to the injury of others and in violation of the fiduciary duties imposed upon him by law and by this instrument.

V. Substitution. If my above named Attorney-in-Fact shall be unwilling or unable to serve as my Attorney-in-Fact (and if I am then incompetent to appoint a successor) by appropriate written instrument duly executed, probated and recorded in the Office of the RMC for Greenville County, South Carolina, Claude E. Hopper, the husband of my wife's sister, Mary Nell Pennel Hopper, may designate such substitute, including himself. Any such substitute shall have all the powers given to the original one.

VI. Accounts. It shall not be necessary for my Attorney-in-Fact to render any inventories or accounts.

VII. Recordation. This Power of Attorney shall be recorded in the Office of the RMC for Greenville County, South Carolina.

VIII. Ratification. I ratify and confirm all things heretofore done for me or in my name by the above named person.
