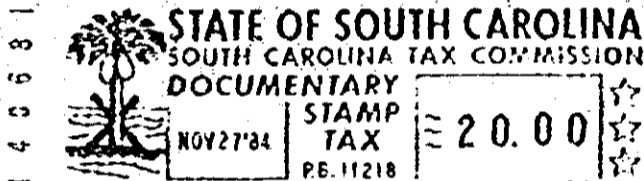
Clyde B. Bridges & Hazel N. Bridges, their heirs and assigns forever:
