KNOW ALL MEN BY THESE PRESENTS, that I, P. C. HIGGINBOTHAM, of the aforesaid County and State, have made, constituted and appointed and by these presents do make, constitute and appoint WARREN B. HIGGINBOTHAM, of the State of New York, my true and lawful Attorney in Fact, for me and in my name, to do and perform the following matters and things:

(a) To make bank deposits, to endorse any checks, to sign and issue checks in my name and on my account/accounts at such bank or banks wherein I have account, and to withdraw money from any savings account at any bank/banks or other such institutions where I might have a savings account, including, but not limited to savings and loan associations; to sell, dispose of and collect for any stocks, shares or certificates of any corporation or business included among which, but not limited to stock of savings and loan associations

(b) to ask, demand, sue for, recover, collect and receive all sums of money, debts, dues, accounts, legacies, bequests, interests, dividends, annuities and demand whatsoever as are now or shall hereafter become due, owing, payable or belonging to me and have, use and take all lawful ways and means in my name or otherwise for the recovery thereof, by such legal means as may, in the discretion of my Attorney in Fact be necessary and to compromise and agree for the same or other sufficient discharges for the same and for me and in my name to make, seal and deliver

(c) to bargain and agree for, buy, sell, mortgage, hypothecate and in any and every way and manner deal in and with goods, wares, merchandise, chose in action, any other property in possession or in action; and to make, do, transact and carry on all and every kind of business of whatever kind or nature; and also for me and in my name and as my act and deed to sign, seal, execute, deliver and acknowledge such deeds, leases and assignments of leases, covenants, indentures, agreements, mortgages, hypothecations, bills, bonds, notes, receipts, evidences of debts and such other instruments in writing of whatever kind and nature as may be necessary or proper in the premises

(d) to bargain, contract, agree for, purchase, receive and take lands, tenements and to accept the seizing and possession of lands and deeds and other assurances, in the law therefor, and to lease, let, demise, bargain, sell, remise, release, convey, mortgage and hypothecate lands, tenements and herditaments, upon such terms and conditions and under such covenants as my Attorney in Fact shall think fit and desirable, all within discretion of my said Attorney in Fact

(e) to enter into any lock box, safety deposit vaults or any other place of safekeeping, in my name and stead, into or onto which I personally would have the right to enter, and to rent other vaults, lock boxes, or places of safekeeping in my name and stead, and to have free access thereto whenever my Attorney in Fact may deem it advisable.

THIS POWER OF ATTORNEY is executed pursuant to the provisions of Chapter 47, Article 6, Section 47115.1 of the General Statutes of the State of North Carolina, it being my express intention that this Power of Attorney shall continue in full force and effect notwithstanding the incapacity or incompetence of myself.
