the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Charles B. Campbell, his heirs and assigns forever:

ALL of my undivided right, title and interest in and to ALL that piece, parcel or lot of land in Greenville Township, County and State aforesaid, being known and designated as Lot No. 14, Block Y, of Riverside, and having, according to survey made by R. E. Dalton, February, 1944, the following metes and bounds, to-wit:
