Dorothy R. Cothran, her heirs and assigns forever:

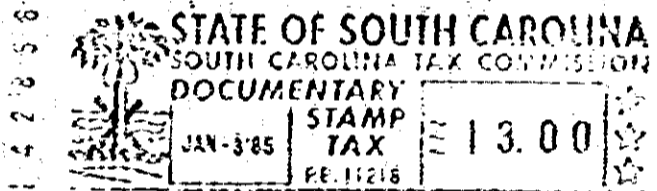
