release unto MILTON SHOCKLEY, his heirs and assigns forever;

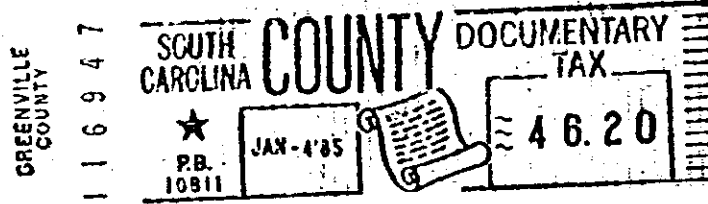
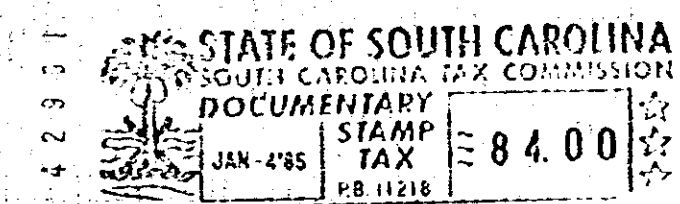
All that certain piece, parcel or unit, situate, lying and being in the
