KNOW ALL MEN BY THESE PRESENTS, that N. Barton Tuck, Jr. (hereinafter referred to as "Grantor") in the State aforesaid, in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, the receipt of which is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto RIVERBEND INVESTORS LIMITED PARTNERSHIP, a South Carolina limited partnership (hereinafter referred to as "Grantee"), its successors and assigns, forever:

All that certain piece, parcel or unit, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Unit No. 103 of Riverbend Horizontal Property Regime, the Master Deed for which is recorded in the RMC Office for Greenville County in Deed Book 1174 at pages 91 through 165, inclusive, and subsequently amended on September 23, 1982 and recorded in the RMC Office for Greenville County, South Carolina in Deed Book 1174 beginning at Page 390. — 26-500-202.1-1-103

This being a portion of the property conveyed to the Grantor herein by Deed of N. This conveyance is made subject to all restrictions and easements as set out in the Master Deed and Exhibits attached hereto and otherwise shown in the public records, and to the Mortgage of The Seamen's Bank for Savings originally recorded on June 2, 1972 in Mortgage Book 1235 at page 637, and subsequently amended by various instruments, the most recent of which was the Modification and Amendment of Mortgage and Note recorded September 24, 1982 in Mortgage Book 1581 at page 410.
