



 Daniel Ford the same was Ordered to be Recorded...

 Smith <sup>his</sup> This Indenture Made this seventeenth day of August One  
 to Jesse <sup>his</sup> Thousand seven hundred and Eighty seven, Between Drury Smith of the  
 Ford <sup>his</sup> District aforesaid planter of the one part and Jesse Ford of the Other  
 Lease <sup>his</sup> Part Witnesseth that for and in Consideration of the sum of one Shil-  
 ling and Six pence Current money of this State aforesaid to him the said  
 Drury Smith in hand paid at and before the sealing and delivering the  
 Receipt whereof he doth hereby Acknowledge him the said Drury Smith  
 hath Bargained and sold and by these presents doth bargain and sell  
 unto the said Jesse Ford his Executors Administrators and assigns  
 a Tract or parcel of land containing one hundred acres more or less  
 Situate in Ninety Six District on the Reedy fork of Reedy River

bounded on Drury Smiths land on the south side on all other sides vacant and not  
 such shape forms and marks as the plat Dirs do thereof to the Grant annexed  
 Together with all and singular all that tract of One hundred acres of land ly-  
 ing and being on the Reedy fork of Reedy River Together with all Ways,  
 Wells, Waters, Water courses, Easements, Profits, Commodities, Advantages,  
 and Emoluments, Hereditaments and Appertinances whatsoever to the  
 said Drury Smith Belonging or in anywise Appertaining and the Re-  
 version, and Reversions, and Remainder, and Remainders thereof and  
 and Every part and part thereof To have and to hold the said  
 Tract of land and all other the premises unto the said Jesse Ford his  
 Executors Administrators and assigns for the day next after the date  
 of these presents, for and during the term of one whole year from thence  
 next Ensuing to be complete and ended Yielding therefore unto the  
 said Drury Smith his Executors Administrators the <sup>rent</sup> of one pecker  
 Corn the last day of the said term if the same shall be Lawfully de-  
 manded to the Intent and purpose that the said Jesse Ford by virtue  
 hereof and by the force of the statute for Transferring uses in to posses-  
 sion may be in the Actual possession of the premises herein before  
 mentioned and hereby Enabled to accept and take Grant and Release of  
 the Reversion and Inheritance of the same to him and his heirs for-
