This Indenture made the twenty fifth day of August one thousand seven hundred and eighty eight and of the Independence of the United States of America the thirteenth, between William Story of Greenville County and State of South Carolina planter of the one part, and Edward Box of the County of Laurens and State aforesaid of the other part Witnesseth that the said William Story for and in consideration of the sum of thirty pounds Sterling to him ~~then~~ in hand paid the receipt whereof is here by Acknowledged the said Edward Box William Story hath bargained and sold aliened and confirmed and by these presents doth bargain sell alien and confirm unto the said Edward Box his heirs and assigns (in his actual possession) all and singular that plantation or tract of land containing fifty acres of ^{land} more or less being part of a tract of land containing two hundred acres granted to said William Story by his Excellency William Moultrie Esq bearing date July the fourth seven hundred & eighty four, Situate in the district of Ninety six, beginning at a Dogwood and Running thence S 40° 22' 35" to Stake corner thence N 65° 22' 35" to a Beech corner thence N 45° 22' 35" and from thence N 50° 22' 35" to the beginning, bounded N & E by said William Storys land, & on all other sides vacant when originally granted, Together with all and singular the woods underwoods, timber and timber trees Lakes ponds, waters and water courses, Commons and Common of pasture, profits Commodities, privileges and Hereditaments to the same respectively, belonging or in anywise appertaining and the Reversion and Reversions, Remainder and Remainders, Rents Issues and profits thereof To have and to hold the said plantation
