The following Deed of Conveyance from William Clark to
 Peter Aker being proven before Humphrey Cobb Esqr. by the oath
 of Edwin Smith was presented & recorded this 22 Day of Aug. 1795
 This Indenture made this twenty fourth day of November in the year
 of our Lord one thousand seven hundred & Ninety four, between William
 Clark of Greenville County & State of South Carolina of the one part &
 Peter Aker Senr: of Pendleton County & State aforesaid of the other part
 Witnesseth that the S: William Clark for & in Consideration of the sum
 of thirty five pounds, Lawful Sterling money to him in hand well & tra-
 ly paid by the S: Peter Aker at & before the sealing & Delivering of this
 presents the Receipt thereof the S: William Clark doth hereby acknowledge
 & that of, & from every part & parcel thereof, do acquit & discharge the S:
 Peter Aker his heirs & assigns, & for Divers, other Good Causes & Considerations
 him unto moving him granted, bargained, & sold, Alliened, Enfeoffed & conveyed
 unto the S: Peter Aker his heirs & assigns forever, all that parcel or
 Tract of Land lying & being in Greenville County & Washing ~~the~~ State
 sit, on the north Side of Saluda River, bounded on the Corner on the
 River by a red oak, N 13, 44, 63 Corner on a stake, S 80 E 45 Corner
 on a Stake, N 10 E 62. 50, & by the ~~River~~ by vacant Land Saluda
 River on the other Side having Majamillions Corner near the river
 & all other sides by vacant Land at the time of Surveying
 containing two hundred acres, originally granted to William
 Clark & signed by his Excellency William Moultrie Esqr. on the
