The following deed of Conveyance from James Ritchey to Elias
 Earle being proven before John Blasingame Esq^r by the oath of
 Isaac Green was presented and recorded this 19th day of Oct^r 1796
 State of S^c Carolina } I know all men by these presents that I
 Greenville County } James Ritchey of the State of Tennessee for &
 in consideration of the sum of two hundred pounds to me paid by
 Elias Earle of the County & State aforesaid, have granted bargained sold
 and released and by these presents, do Grant bargain sell & release
 unto the said Elias Earle, all and both of the Tracts of Land granted to
 me laying and being in the aforesaid County on the waters of Richland creek
 a branch of Needy River, Joining land laid out for David Goodlett, John
 Timmons, W^m Giles & Joseph Langston. being the land where the said Elias
 Earle now lives, now one tract of the above land granted to James Ritchey
 the sixth day of June 1788 for the sum or quantity of Two hundred acres
 the other granted the twenty first day of January 1785 both from under
 the hand & seal of his Excellency Benj^l Guv^r. Esq^r containing in all
 four hundred and eighty five more or less within the bounds & courses as
 by the grants may more fully appear together with all and singular the
 rights members hereditaments and appurtenances to the premises be-
 longing or in any wise incident or appertaining to have and to hold
 all and singular the premises before mentioned unto the said Elias
 Earle his heirs and assigns for ever and I do hereby bind my heirs Ex-
 cutors Administrators to warrant and for ever defend all & singular the
 premises unto the Elias Earle his heirs & assigns against myself my heirs
 and every other person whomsoever lawfully claiming or to claim the
 same or any part thereof, witnesses my hand & seal this 28th day of
 September one thousand seven hundred and ninety six and in the
