 August the seventeenth day in the year of our Lord 1790 This Indenture made between Shadrach Murray of the State of North Carolina Washington County of the one part & Labon Loftis of the State of South Carolina Ninety six District witnesseth that the said Shadrach Murray for and in consideration of the sum of sixteen pounds Ten Virginia money to him in hand paid by the said Labon Loftis, the receipt whereof the said Shadrach Murray doth hereby acknowledge, he the said Shadrach Murray hath granted bargained and sold aliened and confirmed and by these presents doth grant bargain and sell alien and confirm unto the S<sup>r</sup>. Labon Loftis his heirs and assigns for ever all that messuage & all that piece or parcel of land containing one hundred and fifty acres situate in the district of ninety six north side of Saluda on the East branches of South Sygar River, and also all trees, woods under woods tithes commons common of pasture profits commodities Advantages hereditaments ways waters & appurtenances whatsoever to the S<sup>r</sup>.
