The following deed of conveyance from W^m. Powell Riddell to Edward Howard
 being proven before James Helgou Esq^r. by the oath of William Gilbert was
 presented and recorded this 3rd day of April 1797
 This Indenture made this fifteenth day of December one thousand seven
 hundred and ninety four and in the eighteenth year of American
 Independance between William Powell Riddell of Laconton County Orera
 burgh district of the one part, & Edward Howard of the County & State
 of said planter of the other part whereas in & by a certain Grant bearing
 date the seventeenth day of April 1788 under the great seal of the State signed
 by his Excellency Thomas Pinckney Esq^r. Govern^r & Commander in Chief in
 and over s^t. State for that purpose appointed did give and grant unto
 Andrew M^r. Taren a Tract of land containing two hundred acres situated
 in Greenville County Pendleton District on branch of Rabourns creek waters
 of Needy River, the s^t. Andrew M^r. Taren to William Powell Riddell by a
 Deed of conveyance the s^t. two hundred acres of land now this Indenture
 Witnesseth that the s^t. W^m. Powell Riddell do bargain & sell fifty acres of
 the above mentioned tract it being the north part begining on a red
 oak running So 12 ch to a stake c^t. now due wth 40 ch to stake c^t. on the other
 line then s^t. on s^t. line 20 ch & fifty links to post oak c^t. of s^t. Original
 Grant, then S^t. 78 E 21-15 to a stake c^t. thence on Edward Howard's line
 on two Squares to the begining red oak c^t. which Includes the full quan-
 tity of land be the same more or less with all & singular the appurten-
 ances thereunto belonging the houses buildings gardens orchards or in
 any wise appertaining unto the only & proper & absolute use & behoof
 of him the s^t. Edward Howard his heirs Ex^t. Adm^r. or assigns &
 he the s^t. Edward Howard his heirs or assigns shall & may from time
 to time & at all times hereafter have hold use occupy possess & Enjoy
 the s^t. plantation or tract of fifty acres of land without any manner
 of Troubb hindrance molestation interruption or denial of him
 William Powell Riddell his heirs Ex^t. Adm^r. or assigns and lastly
 the s^t. William Powell Riddell from all person or persons whatsoever
 himself his heirs or assigns unto the s^t. Edward Howard his heirs or assigns
 will warrant & for ever defend the s^t. plantation or tract of land
 in witness whereof he the s^t. W^m. Powell Riddell hath hereunto set
 his hand & Seal the day & date first above written
