 survey 14: 25 to stake st thence N 16: 6 on said line 16: ch: to the said river
 again thence down the various courses of S. River to the begining pine corner
 which includes the land to be conveyed bounding on the N. by Enoree
 River on the East by Thomas Revils own land on the by Joab League
 Land on the W. & N.W. by old north granted land including the plantation
 whereon said David Bradley now lives fifty acres of said land being a
 part of a tract of 200 acres Originally granted to Robert Goodwin by
 Patten bearing date the 3^d day of October 1785 recorded in grant Book
