The following Deed of Conveyance from William Story to James Chastain being proven before Thomas Camp Esq^r by the oath of Henry Burrow was presented and recorded this 20th day of April 1797
 This Indenture made this the eighteenth day of February in the year four Lord one thousand seven hundred & ninety seven between William Story of the State of South Carolina Lowville County of the one part & James Chastain of the State and County aforesaid of the other part witnesseth that the said William Story for and in consideration of the sum of sixteen pounds to him in hand paid by the said James Chastain the receipt whereof is hereby acknowledged he the said William Story hath bargained and sold aliened & confirmed and by these presents doth bargain & sell alien and confirm unto the said James Chastain his heirs and assigns for ever a plantation or tract of land containing by Computation fifty acres of land situate in Greenville County on Little Horse Creek beginning on a post oak st running thence on Burrows line S 50 W 45 chains to a stake & thence N 40 W 18 chains on Jacob Neighbors line to a stake & thence N 60 E 46 chains on John Hugers line to a stake & thence S 40 E to the beginning (being part of a Tract of two hundred acres of land Originally granted to the said William Story) Together with all woods underwood timber & Timber trees, tithes common, advantages hereditaments, ways, waters and appurtenances whatsoever therunto belonging or in any wise appertaining and also the reversion and remainders rents & services of the said premises and of every part thereof and all the estate right tittle Interest claim and demand whatsoever of him the said William Story of in or to the same to have and to hold the said tract of Fifty acres of land (be the same more or less) and all & singular the premises above mentioned and every part & parcel thereof with the appurtenances unto the said James Chastain his heirs and assigns for ever and the said William Story for himself and his heirs the said Tract of fifty acres of land (more or less) and every the premises therunto belonging against himself his heirs Executors Administrators, and every other person or persons whatsoever unto the said James Chastain his heirs and assigns shall and will warrant and for ever defend by these presents In witness whereof the said William Story hath herunto set his hand and affixed his seal the day and date first above written, Signed Sealed & Delivered in the presence of Test Philip Mulkey
