The following deed of Conveyance from Frederick Craft to John Craft  
being proven before John M. Elroy Esq<sup>r</sup> by the oath of James Ash-  
more was presented and recorded this 30<sup>th</sup> December 1799  
State of South Carolina I know all men by these presents that  
I Frederick Craft Sen<sup>r</sup> of the County of Greenville and State afo-  
said for and in consideration of the sum of Sixty pounds lawful  
Current money to me paid by John Craft of the said County & State  
have granted bargained sold and released, and by these presents  
do grant bargain sell and release unto the said John Craft all  
that Tract or parcel of Land Situate lying and being in the afo-  
said County of Greenville and on both sides of Reddy River convey-  
ed by a Deed of Conveyance to him the said Frederick Craft by Lewis  
Devall of Laurens County & State aforesaid bearing date October  
the seventh day Anno Dom<sup>i</sup> one thousand seven hundred & ninety  
seven for two hundred and ninety two acres be the same more or  
less by reference therunto will fully appear being the Tract & land
