

The following Deed of Conveyance from Hugh McWay to Lewis Land
 being proven before John Tabb Esq. by the oath of Moses Eastis was
 presented and Recorded this 11th day of January 1798.
 This Indenture made this twenty ninth day of July in the year of our
 Lord one thousand seven hundred and ninety seven and in the twenty
 first year of American Independence between Hugh McWay Senr. of
 Greenville County State of S. Carolina of the first part and Lewis Land of the
 County and State aforesaid of the second part witnesseth that the said Hugh
 McWay for and in consideration of the full and just sum of twelve pounds
 to him in hand paid by Lewis Land the receipt whereof I do hereby acknow-
 ledge hath granted bargained and sold and by these presents do grant
 bargain sell and deliver unto the said Lewis Land his heirs and assigns for
 ever in fee simple one certain tract of land lying and being in the District of
 Washington on the waters of Enoree River containing Sixty acres more or
 less being part of a tract Originally granted to Robert Prince as may more
 fully appear by a plat and Grant given to said Prince on the twentieth day
 of March one thousand seven hundred and Eighty seven as appears by
 Record in Surveyor Office in Grant book V.V.V.V. page one hundred and forty
 four begining at a red oak corner on said Land's line, thence along said line
 to a black corner on John McWay line, thence along s^d. McWay line to a post
 oak corner, from thence along a conditional line to a post oak corner made
 by s^d. McWay and Land at the head of a short branch, thence down a branch
 to the begining to have and to hold the above granted land with its appur-
 tenances hereto belonging unto him the said Lewis Land his heirs and af-
 figns for ever and from and against the claim or claims of any persons
 whatsoever and the said Hugh McWay doth for himself his heirs and assigns
 all or either of them do warrant and defend the above granted premises
 with its appurtenances unto him the said Lewis Land his heirs and assigns
 for ever in witness whereof I the sd Hugh McWay have hereunto set my
 hand and seal the day and year first above written. I interlined
 before signed in these words (Twenty ninth above all).

 and Recorded this 11th day of January 1798.
 This Indenture made this Twenty fifth day of May one thousand seven
 hundred and ninety seven between William Tubb of the State of South Caro-
 lina and County of Greenville of the one part and Lewis Land of the aforesaid
 State and County of the other part witnesseth that the s^d. Wm. Tubb for the
 consideration of the sum of Eighty pounds paid by the said Lewis Land
 the receipt whereof is hereby acknowledged that I the s^d. Tubb have granted
