

This Indenture made this tenth day of March in the year of our Lord  
 One thousand eight hundred and two between James Kelly of Greenville  
 District and State of South Carolina of the one part and Moses Kelly  
 of the State and District above mentioned of the other part witnesseth  
 that for and in consideration of the sum of three hundred Pounds  
 lawfull Sterling money of South Carolina to him the said  
 James Kelly in hand paid by the said Moses Kelly the receipt  
 whereof he doth hereby Acknowledge and every part and parcel  
 thereof as acquit and discharge the said Moses Kelly his heirs  
 and assigns for ever - Have given granted sold Conveyed & Confirmed  
 and by these Presents do give grant sell and Confirm unto the Moses  
 Kelly his heirs and assigns forever. One certain Tract of land  
 Situate lying and being in Greenville District lying on both sides  
 of Reedy River, Containing Eight hundred and twenty Acres be  
 the same more or less, it being a Tract of 640 acres granted to  
 John Winn On the 16<sup>th</sup> day of July 1784. lying on both sides of Reedy  
 River - AKA "Sixty acres" a part of a Tract granted to Tully  
 Choice, adjoining the said Winn's line and on the south W.  
 by Reedy River, and on the East by W<sup>m</sup> Choice land - Also 50  
 acres of land more or less joining s<sup>d</sup> Winn's line on the W<sup>e</sup> side of  
 Reedy River below, bounding on Pugton Howlins land & Jipe Webb,  
 to David Hugger old line - Also Sixty acres more or less, part of two  
 tracts of land, one of them granted to Hewlet Swellington & the other  
 to Mary Burns, bounded from Hugger old line to Jipe Webb line  
 & John Story's line and Thomas Powers line to s<sup>d</sup> Mary Burns'  
 line then along s<sup>d</sup> ~~Allen~~ line to Winn's old line, thence along  
 Winn's line agreeable to the original estate. Together with houses  
 orchards gardens, meadows, pastures, feedings, fences Woods & timber woods,  
 ways water and Water Courses together with all the Estate right title  
 possession Interest Claims and demands whatsoever of him the s<sup>d</sup>  
 James Kelly in or to the same or any part of the premises & his  
 remainder and successors of all & singular the aforesaid land  
 premises, and every of their appurtenances: To have and to hold  
 the said Eight hundred acres of land more or less, & dwelling with  
 their appurtenances unto the said Moses Kelly his heirs & assigns  
 to their & their only proper use & behoof for ever free & clear from  
 all incumbrances whatever - and further the said James Kelly do  
 himself his heirs or assigns, do Covenant & Agree to & with
