The State of South Carolina Know all men by these Presents that I James Lewis of Greenville District in the State aforesaid for and in consideration of Fifty dollars to me in hand paid by Reubin Smith Junr. of the State aforesaid. I have granted bargained & sold and by these Presents do grant bargain & Release unto the said Reubin Smith Junr. all that Tract or Parcel of Land containing Twenty five Acres, it being a part of a Tract of two hundred and fifty Acres Originally granted to Joshua Sanders the 21st day of January 1785. and recorded in grant Books C.C.C.C. page 384. Situate in the State and district aforesaid, on the N^o side of the head of Peter Creek, the land to be conveyed, being on a Stake Corner, old, made between S. Lewis & Isaac Towers thence runs on S. Joshua Sanders line N. 60 W. 27. 50 to a Chestnut Corner & thence S 30. W. 9. 10 to Stake Corner, thence through S. Trask S 60 E. 27. 50 to Stake Corner, thence N. 30 E. 9. 10 to the beginning Stake corner which includes the land to be conveyed, be the same more or less. Together with all and singular the Rights members hereditaments & appurtenances as, thence belonging or in any wise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said Reubin Smith Junr. his heirs Executors & Assigns for ever. And I do hereby bind myself my heirs Executors & Assigns to warrant and for ever defend the aforesaid premises unto the said Reubin Smith Junr. his heirs Executors & Assigns against myself my heirs, Executors & Assigns & against every other person whomsoever, lawfully claiming or to claim the same or any part thereof - Witness my hand & seal this 7th of September 1801 One thousand eight hundred & One. & in the twenty sixth year of the Independence of the United States of America -
