5<sup>th</sup> South Carolina Know all men by these presents that I Joseph Dill Signer of Greenville District & State aforesaid Inconsideration of the sum of fifty Dollars to me J. Dill by Joseph Dill Junr. of said District I have granted bargained sold & Released by these presents do grant Bargain Sell & Release unto the said Joseph Dill Junr. A plantation or Tract of Land Lying and being in Greenville District & State aforesaid on the waters of South & middle Tyger River at the East of Fox Mountain, Beginning on a Chestnut oak by a large Rock running thence N. 10. W. 54. Ac. 1/2 to a Chestnut corner thence S. 70. W. 18. 26. to a conditional Stake corner, thence N. 70. E. 54. 72. to a Stake corner on the other line, Near Daniel Datus corner, thence N. 20. E. 18. 26. to the beginning Chestnut oak corner, Containing one hundred acres more or less, the same being part of a three hundred acre tract of Land granted to Patrick Shaw on the twenty first day of January 1785. And by the said Patrick Shaw sold and conveyed to Joseph Dill Junr.

Together with all and singular the Rights murther Hereditaments and Appurtenances to the said Premises Belonging or in any wise Appertaining, To Have & to hold all and singular the premises before mentioned to the said Joseph Dill Junr. his heirs and assigns for ever, and I do hereby bind myself my heirs Executors & Administrators to warrant and for ever defend all and singular the said premises unto the said Joseph Dill Junr. his heirs and assigns against myself & my heirs and against all and every other person whomsoever lawfully claiming or to claim the same or any part thereof In witness whereof the said Joseph Dill Junr. I have here unto set my hand and affixed my seal this tenth day of March in the one thousand and eight hundred and fourth in the Twenty eighth year Americas Independence - Signed sealed and delivered in the presents of us the witnesses -
