Know all men by these presents that we Jessy Chandler and Charles Ester ^{of} of Greenville County and estate aforesaid in consideration of Two hundred dollars to me paid by William Scott of the State of North Carolina & County of Burke, have granted bargained sold and Released unto the said William Scott all that plantation or tract of Land which he now lives on situated in the County aforesaid lying on the waters of Mountain Creek, of Saluda river containing one hundred and twenty eight acres be the same more or less, beginning on a maple OX being thence N. 76. 54. 50 on John Matlock line to a stake OX thence South 19 West 7 chances on said Matlocks line to a stake OX thence East 12. 50 on land Hendrick Arnold deceased thence North 21 West 24 chances on William Jones line, to read oak OX thence S. 67. W. 24. 50 on Judiah Ester line to read oak OX. Near the head of a branch thence down the Meanders of said branch to a branch thence on Beaver Dam Creek thence down the Meanders of said Creek to the beginning. (Being part of two Surveys of Land, one granted to William Wood the other granted to Patrick Laffarty - Together with all and singular the Rights, Members, Hereditaments and appertinances to said premises belonging or in anywise incident or appertaining To have and to hold all and singular the premises
