Know all men by these Presents that I Samuel Neighbours of Lawrence District in the State aforesaid in consideration of one hundred Dollars to me in hand paid by Perry Hollon of Greenville District and State aforesaid have granted, Bargained, sold and Released and by these presents do grant, bargain, sell and Release unto the S^r Perry Hollon a plantation or tract of Land containing one hundred Acres of Land (Be the same or less) situate in Greenville District lying on the Branches of horse Creek waters of ready view Beginning on an oak 3X on a branch running thence S. 47. W. 21. 50. on said line to a pine 3X on Nathaniel Whitlocks line thence N. 42. W. 55. on said Whitlocks and Thomas Hollons line to a stake 3X thence N. 52. E. 14. on John Lovelaces line to a stake 3X thence S. 40. E. 21. on James Lovelaces to a stake Near a branch thence down said branch to the beginning (Being part of a tract of 996 Acres of Land originally granted to the said Samuel Neighbours) Together with all and singular the Rights, members Hereditaments and appurtenances to the said premises belonging or in anywise Incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said Perry Hollon his heirs and assigns forever. And I do hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the said premises unto the said Perry Hollon his heirs and assigns against myself and my heirs and against every other person whomsoever lawfully claiming or to claim the same or any part thereof. Witness my hand and seal this Nineteen day of January in the year of our Lord one thousand Eight hundred and three and in the twenty seventh year of the Independancy of the United States of America
