hand paid by John Thomas Junior, of the said state & County, the receipt whereof I do hereby  
acknowledge, I have granted bargained, sold ~~and~~ released and confirmed unto the said  
John Thomas Junior; in his actual possession now being all that tract or parcel of land contain-  
ing thirty three acres, being part of a tract of eight hundred & seventy two acres of land  
granted to the said William D. Thomas on the third of March D. one thousand seven hundred and  
Eighty Eight (agreeable to a plat of the said thirty three acres of land, hereunto annexed)  
also one other parcel of land containing twenty seven acres, being part of a tract of one thousand &  
twelve acres of land granted to Josiah Culberson, Joseph Mifflin William Love and the said  
William D. Thomas, which said twenty seven acres bounds on land surveyed for Arthur Safford, by  
land surveyed for John Thomas, & by the the said tract of one thousand and twelve acres sit-  
-ate in Greenville County aforesaid on the South fork Tiger river and a branch thereof  
To have and to hold, the said thirty and twenty seven acres of land, to the said John Thomas  
Junr. his heirs and assigns forever, and I the said William D. Thomas for myself, my heirs  
Executors and administrators, unto the said John Thomas Junr. his heirs and assigns, the said  
above described thirty three & twenty seven acres of land with all its premises and appurtenances,
