District in Consideration of the sum of one hundred and a fifty Dollars to me paid by Nathaniel
Jackson of the District aforesaid. I HAVE, granted bargain sold & releas and by these
presents Do Grant bargain sell & releas unto the said Nathaniel Jackson a plantation or tract
of Land lying & being in Greenville District on the waters of Broad Creek of South Tyger river
Beginning on a ash on a branch the beginning Corner of said tract of land Running N. 10 W.
18. to a chestnut corner thence S. 77. till it runs to a corner that William D. Thomas made
on a post oak where he runs off this part of this Land, thence a straight line across the tract
to the back line on the mountain side thence to the Beginning Ash containing by
Estimation one hundred acres the same being part of a tract of land granted to Ruben
Barrett by a patent bearing date the fourth day of ~~May~~ December in the year
one thousand seven hundred & eighty six, and by the said Ruben Barrett sold &
conveyed unto the said John Page including the Improvement Wheren the S^d John
Page now lives, adjoining Land surveyed for Ruben Barrett

Together with all and singular the rights members hereditaments & appurtenances to the
said Premises belonging or in any wise appertaining, To have and to hold all and singular
the premises before mentioned unto the S^d Nathaniel Jackson his heirs & assigns forever
& I do hereby bind myself my heirs Executors & administrators to Warrant and forever defend
& singular the S^d premises unto the S^d Nathaniel Jackson his heirs & assigns Against myself &
my heirs & Against every person whomsoever lawfully claiming or to claim the same or any
part thereof, In Witness whereof I have hereunto set my hand & affixed my seal this
Twenty seventh of November in the year of our lord one thousand Eight hundred and four
& in the twenty ninth year of America Independence, Lint sealed & delivered in
