

This Indenture made this sixteenth day of November in the year of our lord  
 one thousand eight hundred & four between George Sanders of the one part  
 and Joseph M. Gloughlan of the other parts both of the District of Greenville  
 & State of S. Carolina - Witnesseth that the said George Sanders for and in  
 consideration of two hundred dollars to him in hand paid by the said Joseph  
 M. Gloughlan the Receipt whereof is hereby acknowledged in consideration of the  
 same the said George Sanders hath bargained & sold and by these presents  
 doth bargain sell & deliver unto the said Joseph M. Gloughlan a certain tract  
 or parcel of land containing two hundred acres be the same more or less  
 lying & being in the District of Greenville & State of S. Carolina and on the  
 Pinneus Creek Originally granted to Thos. Bell it being part of S. tract  
 Beginning on a post oak 3x it being boxes & Sanders corner running thence with the said  
 tract out for John Wilson to the state corner st. and to the same course to the west  
 line of said land, thence S. 30 W. across the branch of S. Creek 54 ch. to a red oak 3t  
 thence S. 55 E. 55 ch. 75 links to a stake corner st. near a pine thence S. 22 E. ch.  
 50 links to the Beginning Do have and to hold all & singular the premises  
 above mentioned to the said Joseph M. Gloughlan and singular the rights, members,  
 hereditaments & appurtenances rights to the said premises or in any wise inclose  
 or appertain. & the said Geo. Sanders doth hereby bind myself my heirs  
 exec. trust & warrant & power defend the premises above mentioned.  
 the said Joe. M. Gloughlan his heirs & assigns against all persons whosoever  
 lawfully claiming the same or any part thereof recover - - -  
 I, witness whereof the said Geo. Sanders have caused to set my hand & seal  
 this sixteenth of November one thousand eight hundred & four, signed
