


This Indenture made this eighteenth day of May in the year of our Lords one thousand seven hundred and ninety & in the fourteenth year of the Independence of the United States of America, Between Dan^y Kelly of Greenville County State of South Carolina of the one part & Will^m Laffoon of Pendleton County State aforesaid of the other part, Witnesseth that he the said Dan^y Kelly for and in consideration of the sum of twenty five pounds Sterling to him in hand paid the receipt whereof is hereby acknowledged. HAVE granted bargained sold & conveyed and by these presents DO confirm unto the said Will^m Laffoon and his heirs for ever all that tract or plantation of one hundred and eighteen acres of Land granted by his Excellency Charles Pinckney the fifth day of April one thousand seven hundred & ninety being and lying on the E^{ly} & Joining South & north forks of Saluda rivers below & Joining Elias Earles Land also low side on said Earles Land & Joining S^r Laffoons Land at Beginning at a white wood corner on Bank north river & having such courses as the plat describes Together with all profits and Benefits to the only use & behoof of him the said Will^m Laffoon his heirs and assigns forever, and shall at all times hereafter peaceable have hold possess & enjoy said Land & premises above mentioned ~~unto~~ without any hindrance or interruption of him the s^r Dan^y Kelly from or by him or his heirs And Lastly the said Dan^y Kelly do warrant & forever defend the same from all persons by these presents. State of South Carolina, Greenville District, Know all men by these presents that I John Cantrel of Greenville District State aforesaid in consideration of one hundred Dollars to me in hand paid by Elias Earle of the District State aforesaid HAVE granted bargained & sold and by these presents DO grant bargain sell & convey unto the said Elias Earle all that tract or parcel of Land ~~situate~~ situate in said District on the waters of the main Branch of the N^o fork Saluda Beginning on a poplar on a branch of the middle fork Saluda running N^o 40 E^{ly} 1/4 Chain to a poplar on a branch thence up the branch to another poplar thence S^o 74 E^{ly} 24 Chain fifty links to a stake thence N^o 64 E^{ly} 6 Chain 25 links to a white oak thence N^o 74 W^{ly} 22 Chain 30 links to a stake thence N^o 65
