McAfee & William Chandler. Martin Ais & Anthony Griffin with all singular the rights members hereditaments and appurtenances to the & premises belonging to s^r lands or appertaining thereto have & to hold all & every right title the s^r lands before mentioned to William Whorton & his heirs & assigns forever, and we do warrant & defend said lands from us & our heirs & assigns But from no person or persons else whatever. as Witness our hands & seals this 11th Feb^r 1806.
