E. 10 degrees 18 Chains to a post Oak 34 thence N. W. 50 degrees 14 chains to a cypress tree along said fence by the same direction to a sweet Gum on a branch thence down said Branch to the Mouth thence to the Beginning Together with all and singular woods Trees Tithes, Commons, Advantages Hereditaments ways waters and appurtenances whatsoever therunto belonging or in any wise appertaining and also the Reversion and Reversions, Remainder and Remainders Rents and Services of said Premises and of every part thereof. and all the Estate Right Title Interest (or demand whatsoever of them the said Benjamin Arnold and George Martin of in and to the same To Have and To hold. the said tract of Land and all and singular the Premises above mentioned and every part thereof with the appurtenances unto the said Samuel Roberts his heirs and assigns forever and the said Benjamin Arnold and George Martin for them and their heirs the said tract of Land and every of the Premises therunto Belonging or in any way Against them the said Benjamin Arnold and George Martin their heirs Executors and Administrators and all other persons unto the said Samuel Roberts his heirs and assigns shall warrant and forever defend by these presents — In Witness whereof the said Benjamin Arnold and George Martin hath hereunto set their hands and affixed their seals the day & date above Signed Sealed and Delivered in the presence of
