Greenville District in the State aforesaid, for and in consideration of the sum of four hundred
Dollars to him in hand paid by William Thackston Supt. of the State and District aforesaid. I have
granted bargained and sold and by these presents do Grant bargain and sell unto William Thackston
all and every part of that tract or parcel of land containing Two hundred and Thirty five Acres Sur-
veyed for Jacob Davis and granted to him October the 30th day 1786, be the same more or less -
situate in the District and State aforesaid, on both sides of home pin creek and bounded by
Steven Howard, Solomon Hays, Henry Stokes & William Read Lands, Together with all and singular
the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise
incident or appertaining. Then unto to the only proper use and behoof of him the said William
Thackston his heirs and assigns forever and the said John Nations doth hereby bind himself and his
heirs Executors and administrators, to warrant and forever defend all and every singular the
Premises above mentioned unto the said William Thackston, his heirs Executors and assigns
forever, against himself and his heirs Executors and assigns and against every other person or
persons whomsoever lawfully claiming or to claim the same or any part thereof. In witness
whereof I have hereunto set my hand and seal this tenth day of December one thousand eight
hundred and five and in the thirtieth year of the Independence of the United States
