to me in hand paid by Berry Hollow of the State and District aforesaid. Have Granted
bargained Sold and Released and by these presents Do Grant bargain sell & Release
unto the said Berry Hollow a Plantation or tract of Land containing ninety Eight acres
Be the same more or less Situate in the District aforesaid Lyjng on Line Creek waters of Saluda
River. Beginning on an ash 3x Running thence N. 25. E. 8 chains to a Stake 3x Bounding
on Samuel Neighbors' land thence S. 50. E. 50. 60. to a Stake 3x Bounding on the said Sam.
Neighbors and William Brown. thence S. 41. E. 25 chains to a Stake 3x Bounding on Berry Hollow
lands thence S. 50. W. 43 chains to a Hickory 3x Bounding on land laid out to Sam. Neighbors
thence up the meanders of line to the Beginning. (Being part of a tract of 990. acres of
land originally granted to Sam. Neighbors). Together with all and Singular the
Rights members Hereditaments and appurtenances to the said Premises belonging or in any
wise Incidents or appertaining. To Have and To Hold all and a Singular the Premises before
mentioned unto the said Berry Hollow to him and his Heirs and assigns forever. And I do hereby
bind myself my heirs Executors and administrators to warrant and forever defend all and Sin-
gular the said Premises unto the said Berry Hollow to him and his heirs and assigns against myself
