my heirs executors administrators to warrant and forever defend the just rights  
and property of said Negro man Daniel unto the said William Johnson his heirs  
executors Adm<sup>r</sup> and assigns against myself my heirs executors and adm<sup>r</sup> and  
against every other Person or persons whomsoever Lawfully claiming or to claim
