


 that I Matthias Richardson of the District and State aforesaid, for and in consideration
 of the sum of Six hundred Dollars to me paid by John Richardson of Greenville
 District and State of South Carolina. hath granted bargained sold and Released
 and by these presents do Grant bargain sell and Release unto the said John Richardson
 a certain tract or parcel of land Containing one hundred acres more or less, Situate
 in Greenville District, on the Golden Grove creek, it being part of a tract of land
 granted unto John Bowie, Beginning on a Stake on Pendletons line and Running
 S. 45. E. to the Grove creek 46 Chain thence down said creek to a sweet gum corner
 thence N. 62. W. to a white oak, Corner, ^{Ch. 2^d} 13. 60. and from thence S. 84. W. 27. 11
 to a white oak, and from thence N. 23. E. to the beginning. Together with all and
 singular the Rights members hereunto to the said Premises belonging or in any
 wise incident or appertaining. To Have and To Hold all and singular the Premises
 before mentioned unto the said John Richardson his heirs and assigns forever
 And I do hereby bind myself my heirs Executors and administrators to warrant
 and forever defend all and singular the Premises aforesaid. unto the said John
 Richardson his heirs and assigns against myself and my heirs and against every other
 Person or Persons whatsoever lawfully Claiming or to Claim the same or any Part thereof
 Witness my hand and seal this first day of January 1807. And in the 31st year
