 hundred & two, & in the twenty sixth year of America Independence. Between  
 Solomon Hemp of the State of South Carolina, Greenville District, of the one part  
 and William Edwards of the other part of the said <sup>State of</sup> District - Witnesseth that the  
 said Solomon Hemp for and in consideration of the sum of Two Hundred Dollars  
 to me in hand paid. Do bargain sell unto the said William Edwards a certain  
 Plantation or tract of land containing sixty acres more or less, Lying on the south  
 side of Bainbreak branch of the Enoree River, Beginning on a white oak on said  
 branch or near Harry Bensons line Running up said branch to Walter Jacobs line  
 from thence on said Jacobs line to Joseph Edwards line from thence on said Edwards  
 line, down said Bensons line from thence on said line to the Beginning. it being part  
 of a tract granted Anon Hemp in thousand seven hundred and Eighty five - -  
 Together with all and singular the buildings orchards woods and waters, and all  
 the appurtenances thereunto belonging or in any wise Appertaining. Thine To Have  
 and To Hold the said tract of land unto the said William Edwards his heirs forever and  
 he the said Solomon Hemp Do warrant and Defend from him and his heirs to said Ed-  
 wards the above mentioned Premise or from any other person Lawfull Claiming
