part. and Daniel Wilbanks, Carpenter, of the other Part. Witnesseth that Charles Bruce
is seized in fee simple to him and his heirs forever, to a certain parcel or tract of land
containing one hundred acres. Situated in the District of aforesaid, Beginning on a Stake on
Hardin Roberts line thence S: 80. E: 11 ch^{rs} to a Persimmon on said Roberts Spring branch
thence S. 79. E. 30. ch^{rs} to a black oak corner, thence N: 20. ch^{rs} 50. ch^{rs} to a black oak corner
thence N: 42. W: 25. ch^{rs} to a post oak corner, on McMillens line thence S. 78. W: 11.
ch^{rs} to Stake, thence S: 32. W: 4 to the Beginning. and Whereas Daniel Wilbanks
did in Greenville Court enter an action of Debt against Charles Bruce and in which
action such Proceedings were had that at March Term one thousand Eight hundred
and Six there issued an Execution against Charles Bruce for one hundred three Dollars
and thirty two cents & costs as by the Records of said Court will appear, Directed to all
Singular the Sheriffs of said State Commanding of them or either of them that of the
Goods & Chattels land and other Real Estate of Charles Bruce they should cause to be
levied and made the sum aforesaid, and costs & in obedience to said writ of Fi. Fa. & the
said William Anderson did seize & take into Execution all the aforesaid tract a parcel of
land containing one hundred acres be the same more or less. and after seizure & giving due
and legal notice by advertisement and otherwise said on the first Monday in December
sell the aforesaid tract of land to Daniel Wilbanks for the sum of fifty dollars he at that
price being the last and highest bidder according to the common usage of such Vendues

sideration of the sum of fifty Dollars to him in hand paid by said Daniel Wilbanks
at or before the signing and Delivering of these Presents the Receipt whereof is hereby acknow-
-ledged, hath granted bargained & sold & by these Presents doth grant bargain & sell unto
the said Daniel Wilbanks all the aforesaid plantation or tract of land
