State of South Carolina Greenville District - Know all men by these presents that  
I Thomas Fisher of the State and district aforesaid for and in consideration of the sum of  
one hundred and fifty Dollars to me in hand paid by Moses Bates of the State and District  
aforesaid the Receipt whereof is hereby acknowledged. Have granted bargained conveyed &  
Sold & Released and by these Presents Do grant bargain sell & Release unto s<sup>r</sup> Moses Bates  
a plantation tract or Parcel of Land containing one hundred and fifty acres of land situate  
in the District on the head branches of Enoree. Beginning on a red oak near Enock Cooksey's  
house running down to a fork of a branch Eastward, thence down the meanders of the  
branch to a maple, thence a South course to a red oak, thence a straight line to a red oak  
Corner laid off for John Subb, thence a north course to the old path then along  
the path to a white oak near the main head of a branch, thence to 6 stakes by the  
Togaloe Road by the sandy hollow, thence along the togaloe Road to Wells line,  
thence to the Beginning - the same being part of two tracts of land granted to John  
Subb by His Excellency William M<sup>ch</sup>trie one Grant of three Hundred & three acres  
Dated May 17 85. the other Grant 206. Dated November 1793. which lands being  
Conveyed from John Subb to Benjamin Benson from Benson to William Subb from  
William Subb to myself. Together with all and singular the Rights members and  
Hereditaments and appurtenances. To Have and To Hold all and singular the  
Premises before mentioned unto the said Moses Bates his heirs and assigns for ever  
AND I do hereby bind myself my heirs Executors & administrators to warrant & for-  
ever defend all and singular the Premises aforesaid unto the said Moses Bates his  
heirs and assigns against myself my heirs and assigns & against all and every other  
Person or Persons whomsoever lawfully claiming to claim the same or any part thereof.
