Have for and in consideration of the sum of fifty Dollars to me in hand Paid by Martin Dye of the District and State aforesaid. Have granted bargained and firmly sold Confirmed & fully Released hereby unto the said Martin Dye a certain tract or Parcel of land Lying in the District of Greenville on the East side of Enoree Joining said River, Containing fifteen acres more or less Beginning at a pine corner from thence running with Goolletts line to a post oak thence thence to a post oak on a red bank thence to a Poplar on the bank of the River, thence down the river to the Beginning, which said tract ^{or Parcel} of land Containing fifteen acres more or less - Together with all and singular the rights members Hereditaments and appurtenances thereunto belonging or in any wise appertaining - To Have and To Hold all and Singular the Premises before mentioned and sold unto the said Martin Dye his heirs and assigns forever, in fee simple, and I do bind myself my heirs Executors Administrators to warrant and forever defend unto the said Martin Dye his heirs and assigns against myself my heirs and all and singular every other Person or Persons whatsoever from setting up any Lawfull claim to the same or any Part thereof - In Witness whereof I hereunto set my hand & Seal the day & date above Written - Signed Sealed and acknowledged in the Presence of - (Enterlined before assigned)
