Know all men by these presents that I John Tabb of Greenville District & State aforesaid, in consideration of the sum of four hundred dollars to me in hand paid by John Burns the receipt whereof is hereby acknowledged, hath granted bargained sold and released, and by these presents do grant bargain sell and release unto the said John Burns a certain tract or parcel of land, containing two hundred acres, to the same more or less, situate in the district aforesaid, on the banks of Enoree river, Beginning on a red oak Robert Prince's corner thence with any line to a red oak, conditional corner, on Benson's land, thence North Sixty degrees west eighteen chains & seventy five links to a Stake in a branch, thence up the meander of branch to an ash corner, thence North Sixty four west twelve chains and fifty links to a lightwood Stake on a path, thence with said path to Stake, thence with Blackwells line, to a red oak corner, thence a straight line to Robert Prince's Post oak corner, thence South twenty four degrees west with Prince's line forty chains to a black corner, thence to the Beginning, being part of a tract of land granted to myself and part of a tract of land granted to Blackwell. Together with all and singular the rights members hereditaments and appurtenances to the said Premises, belonging or in any wise incident or appertaining. To Have and To Hold all and singular the premises before mentioned unto the said John Burns his heirs and assigns forever, And I do hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the Premises above mentioned
