Abston to John M. Beth from M. Beth to Jesse Goodlett from Goodlett to John Ayres and from Ayres to me, Beginning at a stake corner, at the corner of the Street opposite Abston's Shop, running thence S. 15 1/2 W. seventy feet to a stake thence N. 74 1/2 W. two hundred and thirty five feet to a stake thence N. 15 1/2 E. seventy feet to a stake thence N. 74 1/2 East two hundred and thirty five feet, with a row of Sycamores to the beginning, Together with all and singular the rights, numbers, Hereditaments, & appurtenances to the said Premises belonging or in any wise incident or appertaining - To Have & To Hold all and singular the premises before mentioned unto the said Waddy Thompson his heirs and assigns forever. and I do hereby bind myself my heirs Executors and
