 district of Spartanburgh District and State aforesaid, Have granted bargained and
 sold and by these presents do grant bargain sell and release unto the said James
 Hammett, all that tract of Land containing one hundred and twenty acres being
 a part of a tract of one thousand acres originally granted to Benjamin Kilgore Jun^r
 by Patent bearing date the 3rd day of Sept^r 1792 Situate in the State and District
 afores^d including the plantation whereon Moses Butler now lives, Beginning on
 R.O. a dividing corner between s^r Butler & Wood & run N. 23 E. 42 Chains to Stake 31
 then on W^m Jacksons line then on s^r line N. E. 10. to a red oak corner S. 64. E. 17. 50
 to a red oak 34 then S. 30. W. 15. 00 then S. 31. W. 21 then S. 30. W. 19. to P.O. 34 then
 N. 45. W. 22. 00 to the Beginning. Which includes the full land to be conveyed

Together with all and singular the rights members hereditaments & appurtenances
 therunto belonging or in any wise incident or appertaining therunto, and I do hereby
 bind myself my heirs Executors adm^{rs} & assigns to warrant and forever defend all & singular
 the premises above mentioned unto the said James Hammett his heirs Executors adm^{rs}
