South Carolina, Know all men by these presents that I Solomon Kornbueckle of the State aforesaid & Greenville District for and in consideration of thirty five dollars to me in hand paid by Henry & Joshua Benson of the State and district aforesaid, Have granted bargained sold and release and by these presents do grant bargain sell and release unto the said Henry & Joshua Benson a certain tract or parcel of Land containing twenty twenty acres, Beginning on a maple at a branch on John Mayfield's line running S. 40. E. twelve Chains fifty links, along said line to a maple at a branch thence down the branch twelve Chains fifty links, to a sweet gum thence S. 5 N. seven Chains, to a water oak on the N. E. bank of Enoree river thence up the meanders of said River to the mouth of the first branch thence up the meanders of the branch to the Beginning. Bounded by line running S. 40. E. by John Mayfield's N. W. by Solomon Kornbueckle, N. E. by the said Benson's land Together with all and singular the members hereditaments and appurtenances to the said premises belong or in any wise incident or appertaining. To Have & To Hold all and singular the premises before mentioned unto the said Henry & Joshua Benson to them their heirs and assigns forever, and I do hereby bind myself my heirs Executors & Administrators
