This Indenture made this third day December in the year of our Lord one thousand Eight hundred & Eight. between Sam<sup>l</sup>. Gentry of the one part & Joshua Gosnell of the other part, both of the State of South Carolina and Greenville District

Witnesseth that the said Samuel Gentry for and in consideration of the sum two hundred dollars to him in hand paid by the said Joshua Gosnell of State and district aforesaid, witnesseth that s<sup>d</sup> Gentry hath granted bargained and sold released and delivered and by these presence doth bargain sell Release and Deliver unto the said Joshua Gosnell a certain tract or parcel of Land situate lying & being in the State and District aforesaid and on both sides of the sinkhole fork of Sugar River Beginning on a Spanish oak running thence along the Conditional line to a hickory in Joshua Gosnell's line thence S. binding on s<sup>d</sup> Gosnell line to the post oak corner thence binding on Holcomb line where Snoddis line crosses it, thence along said line running N. to a white oak then S. 70 E. 34 to the Beginning corner, with all and singular the rights & premises to the same belonging to Have and To Hold unto said Joshua Gosnell his heirs and assigns forever and s<sup>d</sup> Samuel Gentry doth hereby bind myself my heirs and assigns to warrant & forever defend all and singular the Rights and premises unto the said Joshua Gosnell his heirs and assigns, against myself my heirs and assigns and from all & every person or persons whatsoever Lawfully Claiming the same or any part thereof.
